1. Introduction

2. Code of Conduct

In your role as a member of the Welsh Pétanque Association Executive Committee you should:

Be committed to the values and vision of our Association and safeguard its assets and reputation.

Have a collective responsibility for the operation of our Association.

Ensure a timely response to agreed actions, requests for information and guidance.

Only sign documents on behalf of our Association when you have authorisation.

Only use information and make decisions for the benefit of our Association and not for any personal gain or interest or for any Club, Region or League of the Association.

Use all property and resources of the Association with care and return on completion of your role on the EC.

Use all confidential Information, including information about individuals, with due care.

Be as open as possible about any decisions and actions taken and restricting information only when the wider interest clearly demands. When speaking as an EC member, your comments should reflect current policies even when they do not agree with your personal views.

Avoid accepting gifts and hospitality that might reasonably be thought to influence judgement. You have a duty to declare any gifts and hospitably received to the EC.

Contravention of this Code of Conduct may lead to disciplinary action in accordance with our Association's Disciplinary Procedures.
